

# Persevering to provide care and hope

Beginning in March 2020, when New York City locked down services in the face of the fast-moving and deadly Covid-19 virus, Odyssey House doubled down to keep our clients, tenants, and staff safe.

The following two years have been a rollercoaster of increased demand for treatment and housing services, stringent infectious disease control measures, shortages of essential supplies, staffing concerns, and overloaded hospital and medical systems.

When New York City became the pandemic's epicenter, we continued to focus on what we do best:

- Persevering to provide care and hope for individuals caught up in the spiraling opioid overdose epidemic
- Supporting New Yorkers facing an unprecedented public health pandemic.

This annual report is a snapshot of who we serve and what we do to keep our doors open—together.

We are grateful to our many partners who work alongside us. They helped us prioritize the needs of vulnerable at-risk populations while we adapted treatment and housing services and adopted flexible online administrative functions.

Throughout the pandemic, our exemplary staff stayed on the job and delivered quality services. As New York City responded to the spread of Covid-19, we safely enrolled people in treatment, provided personal protective equipment, and, together with our primary healthcare provider, Damian Family Care Centers, prioritized testing and vaccines.

Our government partners, including New York State Office of Addiction Services and Supports and Office of Mental Health; New York City Department of Health and Mental Hygiene; Substance Abuse and Mental Health Services Administration; and other local social services agencies all provided essential support to keep our programs running.

We also thank the many individual Friends of Odyssey House, the Robin Hood, George Link Jr., and Elizabeth and Barets O. Benjamin Foundations, and so many others for their support.

# Moving forward. Removing barriers.

At Odyssey House, we support the self-help model of care across our residential, outpatient, supportive housing, and recovery services.

For 55 years, we've provided services that engage, stabilize and prepare people to rejoin society as functional parents, spouses, workers, and citizens. We're proud of our contribution to the health and well-being of thousands of Americans.

We're equally proud of the innovative enhancements to the evidence-based treatment models we offer.

Recent advancements in our treatment services build on our foundational premise: that people with chronic substance-use disorders need long-term support. This support must address addiction in conjunction with other challenges, including mental and physical health problems, poverty, homelessness, and discrimination. Our approach views an individual as a whole person, with interrelated challenges and circumstances that require multiple services.

# Combatting the opioid epidemic

Last year, drug-related overdoses claimed the lives of more than 100,000 people. Each of those deaths was preventable and a tragic loss and waste of human potential. The toll is shocking: over 500,000 deaths have been attributed to opioids since the mid-1990s.

In 2015, we began training staff and clients to use naloxone to reverse a suspected opioid overdose, and we incorporated this life-saving approach into our treatment model. It complements Medication-Assisted Treatments (MATs)—such as methadone, buprenorphine, and Vivitrol—primary medical services, prevention of sexually transmitted diseases, relapse prevention techniques, and other harm reduction methods.

#### An integrated approach

Our approach to treatment and recovery recognizes that addiction is a chronically relapsing disorder. Providing social supports that include education, housing, harm reduction, and other services is essential for long-term recovery.

For clients in our residential and outpatient programs, we offer access to MATs and primary medical and behavioral health services. This integrated approach follows every client from initial engagement—via street outreach or admissions referral—to a detailed medical and psychosocial assessment, to placement in an appropriate program.

#### An essential partnership

With co-located Federally Qualified Health Centers (FQHCs) at our two primary residential treatment centers in East Harlem, we can quickly diagnose co-occurring medical or psychiatric issues that affect a client's ability to engage fully in substance use disorder services.

This partnership is essential for our clients, who often enter treatment with undiagnosed or neglected health issues. During the Covid-19 public health emergency, ready access to primary health services enabled us to quickly develop infection control measures, roll out an effective vaccination and testing system for clients and staff, and expand MAT services for clients with opioid use disorders.

#### Art and exercise

As treatments evolve to include MATs and health and wellness components, both art and exercise— formerly regarded as "ancillary" services—have become essential to our recovery mission. Clients and tenants eagerly participate in art projects, finding purpose and beauty in creative expression. Exercise is central to all clients' building of health and re-discovery of physical strength and well-being. Whether lifting weights and practicing yoga in one of our on-site gyms or competing in our Annual 5K race or the NYC Marathon (where over 600 clients, staff, and volunteers have completed the race in the past 15 years), exercise is a central part of recovery at Odyssey House.

The last two years have been quite a journey. Thank you for supporting us.









# RECOVERY IN THE COMMUNITY

The last two years have changed how we all live, work, and look at the world, but what hasn't changed is our commitment to the health of our clients and community. Though we had to pivot many of our activities to virtual spaces, our connection to the people we serve and the neighborhoods we operate in remains as strong as ever.

With the opioid epidemic claiming more lives every year, our Outreach teams masked up, went outside, and taught New Yorkers how to safely administer naloxone, a nasal spray medication used to reverse the effects of opioids. Harm reduction approaches, such as training and access to naloxone, are built into our service systems, and overdose reversal kits are readily available in all treatment and supportive housing programs.

To keep in touch with vulnerable members of our community, we created daily telehealth support groups for anyone who needed them. Our supportive housing tenants' walking group, WeWalkWednesday, hits the pavement every week, regardless of the weather. In these, and many other ways, we found opportunities to support each other through unprecedented crises.


